Masters students who have not obtained a certificate equivalent to "CEFR" B1 level before graduation (according to the school's definition: TOEIC 550 points, national English test intermediate re-examination... etc.), they must take 4 credits. Graduation is only possible after passing the "Practical English I" and "Practical English II" courses.
3. The elective courses in this list of required elective subjects can be applied back to students enrolled before the 109 academic year.
